A WORD FROM OUR PRESIDENT Mary Sharon Moore The Taproot of Transformative Justice "Justice," a hard-sounding word, is actually a *beautiful invitation* to some deeply challenging work. Its work is to "make whole."

Restorative justice aims to restore to *its original beauty, dignity,* and *vitality* that which has been enshackled, defiled, crushed.

Transformative justice aims to advance the human person, the human community (family, society), and the totality of Creation, *to achieve its fullest, authentic self.*

The *taproot* of transformative justice is a deep *intuition* that this human and creational project is worth pressing for, with all our might, because the powers of *resistance* to human and creational flourishing are well-entrenched, monied, organized, powerful.

Transformative justice seeks to *liberate* the potentiality in each person, in society, in each element of Creation, through particular acts, through policies, with particular care for the weakest, the most vulnerable, or hidden, or excluded; the most wounded physically, emotionally, spiritually, morally.

This deep-rooted intuition of wholeness is not merely the Christian claim but the taproot of the world's great spiritual traditions. Jesus prays "that all may be one," *now.* On Earth, as in Heaven. The yearning is divine. How it comes about is our work.

In our mess-of-a-world, where does transformative justice begin? Not "out there" but "in here," in the spaces of attitude, heart, conscience, and courageous action. We know—by the fierce, coordinated, constant pushback it receives—that it's *prophetic* work.

This challenging work is why we call ourselves Church Women *United*—dedicated to the fierce, coordinated, and constant push *forward* toward a world that works for everyone.

DECEMBER ANNUAL MEETING Charlotte Maloney

Our annual meeting was held on Friday, Dec. 1st, at Friends Meeting (Quakers), Eugene. The ladies of Friends Meeting provided a generous table of delicious continental breakfast treats at 10:00. About 20 members arrived and socialized. Anne began the meeting around 10:30, opening with a prayer. Katharine then read our land acknowledgement. Anne then introduced our final climate activist speaker, Aya Cockram, who is the coordinator of Fossil Free Eugene.

Her presentation was titled "Building a Fossil Free Future: Eugene's Campaign for a Just Transition." She showed how over 50 cities across the nation are working to restrict the use of natural gas infrastructure in new buildings as part of the transition to eliminate methane and other pollutants contributing to climate chaos. She explained that Fossil Free Eugene is a coalition of over 20 climate action groups, including several organizations of our local youth climate activists who presented to us this year.

The coalition is asking the Eugene City Council to: 1/ Mandate that new construction in Eugene be built all-electric. 2/ Transition all utilities in the City to 100% renewable energy by 2030. 3/ Facilitate a just transition for low-income and historically marginalized communities through the creation of a Justice Fund to support whole-home retrofits among other critical steps to move from fossil fuels to clean renewable electricity.

The council passed a ban on new construction of homes with natural gas appliances. This ordinance was modeling an ordinance passed by the Berkeley, California, city council. However, in appeal it was struck down as parts being unconstitutional. After NW Natural Gas spent \$1 million dollars on a campaign to place reversing the Eugene ordinance on the May ballot, the Eugene City Council rescinded the ordinance in order to prevent costly litigation.

Petition to support 4,500 University classified workers throughout Oregon There are 4,500 classified workers at Oregon's public universities in their campaign to win working conditions that help students succeed, and wages that allow them to support themselves and their families. Classified staff work at all seven of Oregon's public universities: University of Oregon, Oregon State University, Portland State University, Western Oregon University, Southern Oregon University, Eastern Oregon University, and Oregon Institute of Technology. These workers keep campus buildings open and clean, ensure people on campuses are fed, make sure buildings are heated and cooled appropriately, keep labs and libraries running and available to students when needed, provide student health and housing services, admissions, and so much more. Without the work of classified staff, Oregon's public universities literally could not operate and students would not be educated. Divest Oregon Reinvest in a Fossil Free Future

DIVEST OREGON

This impressive coalition continues to meet monthly with task forces meeting more frequently, plus presents testimony at every meeting of the Oregon Investment Council, which is every 6 weeks. At the last council meeting on December 6, Treasurer Read and the commission were presented with a petition signed by 1,000 Oregonians asking the commission for a climate risk action plan. Coalition member, Nancy Yuill presented statistics on the under performance of investments in coal companies. Internationally respected climate scientist, Dr. Bill Ripple (on Zoom) and Portland Youth Strike leader, Naomi Merkel, presented on the urgency of the climate crisis. The coalition has confirmed that two expects for the January OIC meeting will each make a presentation continuing to push the issue. Coalition leaders met with Treasurer Read in a roundtable format: treasurer Read said he "was not ideologically opposed" to the COAL Act.

The 2024 short session will include introduction of the Clean Oregon Assets Legislation Act 2024. It's being called the COAL bill and if passed would direct toe OIC to phase out investments in coal, stop all new investments in coal, and require council to report to legislature on the phase out.

Ongoing actions: Continuing to speak at Investment Council meetings; Continuing the Right to Know campaign, because PERS members have the legal right to know what is in their retirement investments; Continue gathering information about what is being done about climate risk at the Treasury through public records requests; Continue preparations by supportive legislators who introducing the COAL bill in 2024 short session; and planning a Lobby Day to support the COAL Act Jan. 10.

Since last Vine update, the council issued an audit, which meets one of the original coalitions demands of increase transparency..

Eugene's Hospital and Emergency Department PeaceHealth closed the University District facility December 1, as previously announced. The inpatient Behavioral Health (formerly known as the Johnson Unit) is still open. PeaceHealth has committed to it operating for 9 months. A group has formed to research how we can again have a hospital and Emergency Department in Eugene. There are representatives from Oregon Nurses Association, HCAO, Democratic Socialists of America, Teamsters, Eugene Solidarity Network, CAHOOTS, Fire and Rescue, and others.
